👛 What Operators Do

Water and Wastewater Operators work behind the scenes to protect health and the environment.

Their responsibilities include:

- Monitor chemical feed and other system components and effectiveness of treatment
- Prepare and maintain records of meter readings, tests, equipment, chemical use, correspondence, and customer complaint log.
- Develop a maintenance plan for the treatment plant and distribution system.
- Regularly read meters and gauges, making adjustments as needed.
- Periodically flush distribution system using hydrants and blow-off valves.
- Periodically assess efficiency of system components (e.g., pumps and valves).
- Conduct preventative and routine maintenance on facilities and equipment.
- Conduct frequent system and security inspections.
- Update system maps when a significant change to the distribution system has been made.
- Make all process control/system integrity decisions necessary to maintain the quality and quantity of water delivered to customers.
- Attend training to meet state primacy agency's continuing education requirements.
- Create and follow standard operating procedures (SOPs).

✅ What It Takes

Successful operators bring skill, discipline, and drive to the job. Apprentices should demonstrate:

- A strong work ethic and attention to safety
- Willingness to work varied shifts, including nights and holidays
- Solid math, science, and mechanical aptitude
- Ability to troubleshoot using charts, maps, and logical thinking
- Excellent communication skills – both verbal and written
- Physical stamina and vision for detailed inspection work
- Comfort working in potentially hazardous conditions

Minimum Qualifications

To apply, you must:

-  Be at least 18 years old (birth certificate or driver's license for proof)
-  Have a valid driver's license, insurable at standard commercial rates
-  Hold a high school diploma or GED (submit official transcripts or GED certificate)
-  Be physically capable of performing essential duties safely
-  Own a computer, email address, and internet connection for online training

Upload required documentation:

 Driver's license, birth certificate, HS/GED/college transcript(s), DD 214 if applicable

Direct Entry Opportunities

Submit supporting documentation for potential direct entry if you've completed:

- Job Corps training
- Structured pre-apprenticeship
- Veteran service (DD 214 only – no transcript needed)
- YouthBuild water/wastewater training

What to Expect After You Apply

1. Interview invitation (via Zoom)
2. Summary of interview results
3. Employer interview when a position opens and a Level 2 Mentor is available
4. Interview with WIOA before hiring to confirm funding for RAP
5. Drug screening and background check may be required prior to selection or employment.

Graduation Requirements

To complete the program, apprentices must:

- Complete 4,000 on-the-job training hours
- Finish 288 classroom instruction hours
- Receive 2 satisfactory evaluations
- Attend 4 professional conferences
- Pass NM Environment Department Certification Exams Levels 1 & 2
